DECLARATION OF BASIN AREAS ORDER, 2021

IN EXERCISE of the powers conferred by Section 24 of the Water Act, 2016, the Authority, following consultation with the Cabinet Secretary, hereby designates the following areas as Basin Areas for purposes of the Act: -

1.	This Order may be referred to as the Declaration of Basin Areas Order, 2021.	Short title
2.	In this Order, unless the context otherwise requires- "Act" means the Water Act, 2016	Interpretation
	"Authority" means the Water Resources Authority established under Section 11 of the Act.	
	"Basin Area" means the areas designated as Basin Areas under this Order into which rain water flows into watercourses and shall include aquifers.	
	"County Government" means a county government as provided for under Chapter 11 of the Constitution of Kenya, 2010	
3.	 The following 5 areas are hereby designated as Basin Areas in Kenya: (a) Athi River Basin Area (b) Tana Basin Area (c) Rift Valley Basin Area (d) Lake Victoria Basin Area (e) Ewaso Ng'iro North Basin Area 	Designation of Basin Areas
(2) For administrative purposes, the Lake Victoria Basin Area shall be managed under Lake Victoria North and Lake Victoria South Basins respectively.	
4.	The County Governments falling within the basin areas designated under paragraph 3 of this Order are as contained under the First Schedule of this Order.	
5.	The Authority hereby designates the areas contained in the Second Schedule as Sub-Basin Areas for purposes of the Act:	Designation of Sub-Basin Areas


